Mats Lewan: The digital transformation will be huge – and it has barely started

Digitalization hit the music industry first but digitally-driven change will eventually transform all fields, including health care, finance, transportation, industry, retail and, notably, the legal business.

Mats Lewan, author, international keynote speaker, futurist, consultant, journalist and research analyst focused on the future and on technology, will address the question whether digitalization is a threat or an opportunity and offer the tools for understanding the mechanisms of digitalization and AI, how to respond and how to benefit from this fundamental change, looking in particular at the legal profession.

Dr. Christian Sandström: Disruptive digitalization of legal services – evolution or revolution?

Dr. Christian Sandström is associate professor in Disruptive Innovation at Chalmers University of Technology and the Ratio Institute. His research concerns technological change and the challenges they present for established firms, with a recent focus on the legal market.

In his speech, he will share his insights from the recently published research report concerning how digitalization affects the legal sector in Sweden. Will digitalization of legal services be a fast evolution or a technical revolution?

Francesc Muñoz: Digitalization needs investments in time and money

Francesc Muñoz has been the CIO of Cuatrecasas, the largest independent Spanish law firm, since 1998. After several years with an R&D IT budget, the firm launched last year, partnering with Telefonica, an open innovation call and created Cuatrecasas Acelera, the first legaltech startup acceleration program.

Francesc Muñoz will explain how digitalization and innovation is part of the management of the firm's resources and how this ensures that Cuatrecasas can be able to provide the right tools to the lawyers for the future. The aim of the startup program is to improve internal processes and develop new products and services to attain the most efficient and flexible advice for their clients.

Panel: How will the digitalization trend affect your business?

A panel of legal professionals will address different perspectives on digitalization and disruption. How does digital technology affect the legal market? What challenges and opportunities are currently facing legal practitioners? Is there a sense of urgency - will there be a potential disruption of the legal market or can legal services transform into a new business model to meet the new digital reality?

Richard Tromans: The Augmented Lawyer - How AI will change how lawyers work

Richard Tromans is the founder of TromansConsulting, which advises legal businesses on strategy and innovation, including advising on the adoption of AI systems. He also runs the site Artificial Lawyer, which is dedicated to new developments in legal AI and automation.

In his talk, Richard Tromanswill share his insights on the growing adoption of legal AI and the consequences for the law firm business model. He will look at the growing family of legal AI technology, how legal data is now machine readable and what this new wave of technology will mean for, and change, how lawyers work.

Adam Hembury and Gustaf Reuterskiöld: What does it take to make Al useful in law firms?

Adam Hembury, Director of Innovation, and Gustaf Reuterskiöld, Country Managing Partner Sweden, DLA Piper, will share some of the ongoing innovation projects in DLA Piper from both a global and a local perspective.

How can law firms benefit from digitalization and the use of Al? It is rather difficult to persuade lawyers to embrace a new working method; how do you manage such a change process? What will it take to make Al really useful and adapted to fit the business model?

Panel: New opportunities with AI – is the law ready for Robot Lawyers?

A panel of legal professionals will then discuss new opportunities with AI from different perspectives. AI tool are now being used in the due diligence process, making associates redundant when it comes to tasks like photocopying, pagination and trawling through documents. What tasks cannot be replaced by computers? What new kinds of tasks should associates focus on onwards? Will we see associates programming self-enforcing contracts? Will algorithms be used in legal decision making? Will Robot Lawyers enter the market in a foreseeable future?

Panellists include Christer Norström, co-founder and working chairman of Racefox, Francesc Muñoz, CIO Cuatrecasas, Adam Hembury, Director of Innovation, DLA Piper, and Gustaf Reuterskiöld, Country Managing Partner, Sweden, DLA Piper.

Christer Norström: Digital coaching based on Al and Big Data for personalized services

Digital AI coaching is a new concept that will have a big impact in many professions. The coach concept is based on understanding the domain, learning from data, understanding the user's challenge and current state and the user's goal, and create an efficient plan and to assist in an effective way from the current state to the goal. Christer Norströmwill discuss the use of AI, big data and personalized data and how it can be used to create digital personalized services. He will give a concrete example of using these kind of services in endurance sport.

Paul Cohen: How will technology change arbitration?

Paul Cohen is a barrister as well as the Editor-in-Chief of the Journal of Technology in International Arbitration, and the Co-Chair of the International Task Force of the Silicon Valley Arbitration and Mediation Center. He will share his insights on the future Al trends in arbitration and litigation, with a special focus on the use of technology in international arbitration. Paul Cohen will inter alia explore aspects such as how technology enables arbitrations to be conducted remotely or online as well as rules and guidelines in development in reaction to technological advances that affect the field of international arbitration.

Panel discussion: Future trends with AI in arbitration and litigation

An initiated panel will then continue the discussions on the use of AI in arbitration and litigation. How will the new technology impact access to justice? Can it increase the availability of arbitration by making it cheaper? Internationally online dispute resolution is now being implemented internationally in some less complex legal matters. Could fast online justice be better than no justice? Are we heading towards a future with virtual courts, where judges are being replaced by algorithms?

The panel will be moderated by Patricia Shaughnessy, Director of the Master of International Commercial Arbitration Law Program, Stockholm University. Panellists include Paul Cohen, barrister and the Editor-in-Chief of the Journal of Technology in International Arbitration, Christer Danielsson, Partner, Advokatfirman Danielsson & Nyberg and President of the Swedish Bar Association, and Annette Magnusson, Secretary General of the Arbitration Institute of the Stockholm Chamber of Commerce (SCC).

Patrick Couch: IBM Watson - Introducing the New Guy (aka The Future with AI)

When IBM's AI tech beat the most successful *Jeopardy!* champions back in 2011 it made not only headline news and Watson a household name but it also ushered in what IBM has defined as the *Cognitive Era*. Today, AI reigns supreme on top of the Gartner hypecycle. So what is real and what is not when it comes to AI? Why are luminaries such as Elon Musk, Bill Gates and Stephen Hawking all asking us to be cautious when dealing with artificial intelligence? And if the tech you team up with is of R2D2 caliber doesn't that make you Luke Skywalker?



Johan Engström and Hans Hedkvist: A Pioneering Swedish Al Solution

MAQS has together with another of Sweden's largest law firms and Virtual Intelligence VQ initiated a joint development project for a pioneering legal artificial intelligence solution based on IBM Watson. This solution will analyze agreements in a new way. As it is based on the IBM Watson AI platform, it is a solution which can learn, not only to structure and analyze vast amounts of data, but to actually learn from its own experiences.

At VQ Forum, the solution will be presented for the first time, as well as all project participants. Furthermore, the experiences from the project will be shared with lessons learned as to processes and competences needed for the creation of a successful AI solution within the legal field.
